













PRAVILA PONAŠANJA NA PLAŽI

RADNO JE VRIJEME PLAŽE

od _____ do _____ sati.



Gosti i posjetitelji plaže dužni su se kulturno ponašati te se koristiti plažom bez ometanja i uznemiravanja drugih gostiju i posjetitelja plaže.

Svi gosti i posjetitelji plaže moraju biti propisno odjeveni u kupaći kostim, odnosno u kupaće hlače.

Sva djeca moraju nositi kupaći kostim. Djeca koja se ne znaju služiti WC-om moraju nositi pelene koje moraju biti prekrivene nepropusnom pelenom za kupanje.

Na plaži je dozvoljeno korištenje loptom i drugim rezvizitima za plažu na način da se ne ometa druge goste i posjetitelje plaže te na za to predviđenom prostoru.

Na području plaže nije se dozvoljeno koristiti skateboardima, biciklima, romobilima, koturaljkama, motociklima i drugim prijevoznim sredstvima i napravama kojima bi se narušavala sigurnost gostiju i posjetitelja plaže.

Gosti plaže mogu unajmiti ležaljke i suncobreane uz nadoplatu prema odgovarajućem cjeniku te ovisno o raspoloživosti.

Djeca do 14 godina starosti na plaži moraju biti u pratnji punoljetne osobe.

Radi vlastite i sigurnosti drugih gostiju i posjetitelja plaže nije dozvoljeno plivati iza zaštitne ograde niti skakati sa zaštitnih građevina na moru.

Upotreba dječjeg igrališta dopuštena je samo uz nadzor odraslih osoba i na vlastitu odgovornost.

Na plaži i području plaže iz sigurnosno-zdravstvenih razloga nije dozvoljeno:

- boraviti osobama pod utjecajem alkohola/ opijata te osobama koje narušavaju javni red i mir;
- točenje alkohola osobama mlađima od 18 godina;
- ulazak kućnim ljubimcima / životinjama;
- kampiranje ni paljenje vatre;
- bacanje i odlaganje smeća (otpadaka, opušaka i sl.) osim na za to predviđenim mjestima.

Za vrijeme održavanja događanja na plaži gosti i posjetitelji dužni su se pridržavati posebnih uputa zaposlenika ovlaštenika koncesije o održavanju reda na dijelu plaže na kojem se odvija događanje.

Gosti i posjetitelji dužni su obavijestiti zaposlenike ovlaštenika koncesije u slučaju uočene bilo kakve opasnosti.

Ovlaštenik koncesije ne odgovara gosta i posjetiteljima za krađe, štete ili ozljede na području pod koncesijom.

U slučaju da zaposlenici ovlaštenika koncesije i/ili zaštitarske službe neposrednim zapažanjem ili po prigovoru drugih gostiju i posjetitelja plaže utvrde kršenje ovih pravila, upozorit će prekršitelje da će u slučaju nastavka kršenja pravila biti udaljeni s područja pod koncesijom, osim u slučajevima kada zbog ponašanja prekršitelja nije za očekivati da će prestati kršiti pravila te će tada prekršitelj biti udaljen s područja pod koncesijom. U slučaju potrebe ovlaštenik koncesije zatražiti će službeno djelovanje nadležnih institucija.

RULES OF CONDUCT ON THE BEACH

THE BEACH WORKING HOURS are from _____ to _____ h.

Guests and visitors to the beach are obliged to behave respectfully and use the beach without disturbing or harassing other guests and visitors.

All guests and visitors of the beach must be dressed appropriately in bathing suits or bathing pants.

All children must wear a bathing suit. Children who do not know how to use the toilet must wear diapers, which must be covered with a plastic diaper for bathing.

It is permitted to use a ball and other beach equipment in the area of the beach predetermined for such activities, but only if it does not interfere with other guests and visitors.

On the beach, it is not permitted to use skateboards, bicycles, scooters, roller skates, motorcycles or other vehicles and devices that would undermine the safety of all guests and visitors.

Beach guests can rent sun loungers and umbrellas for an extra charge according to the price list and depending on availability.

Children under the age of 14 must be accompanied by an adult.

For your own safety and the safety of other guests and visitors to the beach, it is not permitted to swim outside the protective sea markers or jump from the neighbouring sea structures.

Use of the children's playground is only permitted under the supervision of adults and at their own risk.

For health and safety reasons, on the beach and its surrounding area, the following is not permitted:

- Entry to the beach for persons affected by alcohol/opiates and persons who are disturbing the public peace
- Serving alcohol to persons under the age of 18
- Entry for pets/animals
- Camping or lighting a fire
- Garbage disposal (waste, cigarette butts, etc.), except for in the specially marked places

During organized events at the beach, guests and visitors are obliged to abide by the special instructions and rules of the employees of the beach concession holder.

Guests and visitors are obliged to notify the employees of the beach concession holder in case of any danger.

The beach concession holder is not responsible for any theft, damage or injury that may occur to guests and visitors in the concession area.

If the employees of the beach concession holder and/or the security service, through direct observation or the objection of other guests and beach visitors, find a violation of these Rules of Conduct, they are allowed to warn the offenders that if the misconduct continues, they will be asked to leave the concession area. If needed, the beach concession holder will inform the local police authorities.
